Note:- The details of qualifications for the posts of Office Staff shall be determined by the Committee to be constituted by the Vice-Chancellor. The pay scale and other terms & conditions will be as per Punjab Government letter dated 17<sup>th</sup> July, 2020.

**RESOLVED:** The Board of Governors approved the item.

<u>C-6</u>: To consider & approve to enhance the consumption of petrol limit for the use of staff car for official purposes.

The University has Learning Support Centres throughout Punjab and shortly the University shall have at least one Learning Support Centre in all 23 Districts of the State of Punjab. Therefore, the University officers have to travel frequently at different places in whole of the Punjab and Delhi also. As per letter dated 27.07.2021 of the Govt. of Punjab provided by the DCF&A, maximum limit of petrol allowed to an officer is 261 litres per month only. Since, the University officers have to travel frequently at different places, this limit may please be enhanced upto 325 litres per month for travelling within Punjab. However, in case travelling is outside Punjab like Delhi, etc., the petrol consumption be considered in addition to above.

**RESOLVED:** The Board of Governors approved the item to enhance the consumption of petrol limit for the use of staff car for official purposes. The University will approach the Department of Finance, Govt. of Punjab for further clarification.

C-7: To consider and approve the rates for various activities relating to competitive exams for recruitment as well as admissions at par with the rates of Punjabi University Patiala for such activities (Rates of Punjabi University Patiala are attached at Annexure-III of the Agenda).

**RESOLVED:** The Board of Governors approved the adoption of Punjabi University Patiala rates for various activities relating to competitive exams for recruitment as well as admissions.

C-8: Current item:

To consider and approve the proposal for offering courses of the University to the deaf & mute and blind candidates at 50% fee concession. Office note attached as *Annexure-A of the Table Agenda*.

While appreciating the proposal of the University, the BoG members desired that benefit of fee concession be given to those who suffer from not less than 40% of relevant disability. Further, it was also discussed that this benefit should also be granted to all the Persons with Disabilities (PwD), in addition to above categories of disability.

**RESOLVED:** The Board of Governors approved the above proposal for offering the courses of the University to all disabled candidates at free of cost.

## **FOR INFORMATION:**

- <u>I-1</u>: The Govt. of Punjab has approved the Chair in the name of Bhagwan Parsuram Ji to be established at Jagat Guru Nanak Dev Punjab State Open University Patiala.
- 1-2. The University signed Memorandum of Understanding (MoU) with the Institute of Cost Accountants of India (ICAI-CMA) for promoting Excellence inter alia in common area of interest, imparting knowledge and skills required to operate in the area of Academic, Research and Training. Copy of the MoU is attached as Annexure-B.
- 1-3. The University has tied-up with the Department of Police (Prisons) Punjab in order to implement their Project 'Sikhya Daat' Reinvigorating Education System in Prisons Punjab. The Police (Prisons) Department aimed at making inmates of Punjab Prisons literate and to further enable them to become economically self-dependent post release. Copy of the Circular dated 14.12.2021 issued by the Additional Director General of Police (Prisons) Punjab is attached as Annexure-C (75 Jail Personnel had a video-conference with officials of JGNDPSOU on 21.12.2021). Fee will be waived off for Jail inmates as per the norms of IGNOU, but as discussed with Jail officials, Rs.500/- nominal fee will be charged.
- <u>I-4</u>. Indian Accounting Association has established Patiala Branch of IAA at the University. The establishment of this Chapter at Patiala will help in the development of Accounting Education and Profession in this part of the country.
