Sir.

With reference to your mail dated 16.09.2020 on the above subject. I am directed to say that Jagat Guru Nanak Dev Punjab State Open University, Patiala, Punjab has been established with effect from 20.12.2019 by an Act 19 of 2019 notified vide Notification No. 23-Leg/2019 dated 20.12.2019 of the State Legislature of Punjab as a State University and is empowered to award degrees as specified by the UGC under Section 22 of the UGC Act 1956 at its own departments, its constituent colleges and/or through its affiliated colleges in regular mode with the approval of its statutory bodies/councils, wherever required. The name of the University has been included in the list of Universities established as per section 2(f) of UGC Act, 1956 maintained by the UGC on its websit a www.ugc.ac.in

The University shall operate only within the territoria jurisdiction allotted to it under its Act and in no case beyond the territory of the State of its location. The University is not allowed to start any off-campus centre beyond the territorial jurisdiction as provided in the Act and under no circumstances beyond the State of ts location, as per the Hon'ble Supreme Court Judgment in Prof. Yash Pal vs. State of Chhattisgarh case.

The University may note and adhere to the following: -

(i) To ensure that no off campus centre(s)/study centre(s) is opened beyond the territorial jurisdiction of the University as stipulated in the Act and in no case beyond the territory of the State.

To ensure that no programmes should be offered through franchising arrangement with private institutions.

To ensure that no study centre(s) are opened through franchises by the University.

(iv) In case the university has already started any off-campus/study centre and the centre operating through franchises outside the State, it must be closed

- No distance education programmes shall be started without the prior appropriate
  - (vi) M.Phil/Ph.D programmes can be conducted as per the provisions of UGC (Minimum Standards and Procedure for Awards of M.Phil/Ph.D. Degree) Regulations, 2016.
  - (vii) The University is required to follow all the UGC Regulations notified and available on UGC website www.ugc.ac.in.
