You are requested to quote the rates for installation of Internet Lease Line connection of 50 MBPS (Combined), 1:1 dedicated unshared bandwidth over Fiber including necessary hardware at the following transit campuses of Jagat Guru Nanak Dev PSOU, Patiala.

- i. Administrative Block, JGND PSOU, 28-C, The Lower Mall, Patiala
- ii. Examination Block (Agriculture Wing, Govt. Mohindra College, Patiala )
- iii. Academics Block (Govt. State College of Education, Patiala)

All the following conditions must be met by ISP in order to participate in the quote, if ISP fails to provide proof of Class A Category from Govt of India, will be rejected immediately.

- i. ISP should be having a Valid License, Class A Category from Govt of India.
- ii. ISP must have redundancy of International Gateways at their end from Various Service providers.
- iii. ISP must have their own Optical Fiber Network with RING topology.

Following shall be taken into consideration while quoting the rates:-

- a. Rate of GST if extra must be mentioned clearly.
- b. Quotation received later than due date are liable to be rejected.
- c. Quotation must be submitted on letter head of the firm with all particular, any other format will not be acceptable.
- d. The quality of the items to be quoted should be best available in the market.
- e. The bill of the bandwidth will be paid on Quarterly basis.
- f. The services may be extended for another one year after satisfactory completion of the services & if the purchase rules permit at that time.
- g. The sealed envelope must bear the word:-


