## **Terms and Conditions**

- 1. The following conditions must be met by ISP in order to participate in the quote, if ISP fails to provide proof of Class A category from Govt. of India, will be rejected immediately.

  - h) Escalation matrix will be provided by the ISP and 24x7 support will be provided by the university.
  - i) ISP will provided running static 8 IP addressed with no any extra coast.
  - j) Uptime guarantee 99%, throughput 100%
- 2. The sealed quotations in all respects must reach to the Registrar, Jagat Guru Nanak Dev Punjab State Open University, Patiala on or before 19.08.2024 upto 5:00 PM through registered post/Courier /Speed Post.

- 3. The bidder shall strictly abide by the time schedule given by university for delivery of the material /Items as per work order.
- **4.** Validity of the bid is 90 days from the date of opening quotation.
- 5. Selected bidders are strictly prohibited for subletting the assigned work/work order.
- **6.** Incomplete and conditional Quotation will not be accepted.
- 7. The Registrar, Jagat Guru Nanak Dev Punjab State Open University, Patiala reserves the right to cancel the bid without assigning any reason.
- **8.** Copy of Pan Card & GSTN must be attached.
- 9. Payment shall be made in Indian rupees on Final acceptance & after verification by the specified consignees and their issue of clearance & acceptance certificates to the satisfaction of the authority.
- 10. If the service is not provided on or before the due date the competent authority will have the right to deduct 2% of the total bill for every week default, no extension time will be permitted. The decision of the University shall be binding on the bidder in this regard.
- **11.** TDS is applicable as per Income tax rules.
- 12. Quotations will be opened at 20.08.2024 11:00 AM in the committee room of the University i.e. Jagat Guru Nanak Dev Punjab State Open University 28-C Lower Mall Patiala. The firm or its representative can attend the opening of the quotation.
- 13. The rates should be F.O.R. and should include excise duty, sales tax, freight charges, GST and other taxes rates in respect of the supplies. The University shall not be liable to pay any tax, freight etc. Which has not been expressly stipulated in the quotation.
- 14. All disputes, differences, claims and demands arising under or pursuant to or touching the contract shall be referred to the sole arbitrator i.e, the Registrar JGNDPSOU Patiala. The award of the sole arbitrator shall be final and binding on both the parties under the provisions of the Arbitration and Conciliation Act, 1996 or by statutory modification re-enactment thereof for the time being in force. Such arbitration shall be held at Patiala.
